DQ advises on Imperial College London's £200 million Research & Translation Hub

Global Tax Enforcement Conference

DQ recently hosted a hugely successful landmark Global Tax Enforcement Conference which was attended by senior management from many of the Isle of Man's financial services businesses. The aim of the conference was to provide delegates with an understanding of how international governments pursue tax investigations, what best practices can be implemented on a 'going forward' basis to prepare for such an investigation and the implications of various strategies for handling and meeting the challenges of an investigation. DQ's Sinead O'Connor speaks at ICSA conference

FATCA Update

Sinead O'Connor looks at recent developments with FATCA and reminds us that two important dates have now passed in relation to FATCA – 30 June 2014 when Financial Institutions were required to capture details of their existing customers for remediation purposes and 1 July 2014 when Financial Institutions were required to have procedures in place which would enable them to identify US or UK indicia at new business take on. Countries such as Russia, Ireland, New Zealand and Cayman have also been progressing with their FATCA compliance frameworks. Read more.
